**Payment:** A \$500 non-refundable retainer is required upon signing this agreement in order to lock in availability. The cost of the Retainer part of the listed cost in the various Packages. The remaining balance is due 1 month prior to the wedding. Additional costs (such as additional prints, albums, etc.) due upon ordering of said extra goods. The Clients agree to provide a meal for the Photographer if the length of attendance exceeds five hours. We accept cash, checks, and credit cards: Visa, MasterCard, Discover, & American Express. All credit cards have an additional 3% processing fee.

**Pre-Wedding Consultation:** This normally happens at the time of booking. The Clients will outline broadly what is required and the Photographer will advise on planning, logistics and timings where needed. An additional meeting closer to the wedding may be needed as well. In any case, we will contact you by phone a few days before the wedding to ensure that there have been no last minute changes.

**House Rules:** Note that Photographers are sometimes limited by rules imposed by registrars or venue management as to what can and cannot be done. For example some ministers ban flash photography, and others will insist that the Photographers shoot from



a specific location. In such circumstances the Clients agree to accept the technical limitations that may be imposed. We advise the Clients to make themselves aware of the rules of the venue concerned.

**Postponement & Cancellation:** If the wedding time or date is changed by the Clients, the Photographer will make every reasonable effort to be available; however, additional expenses may be incurred. If Photographer is unavailable on the new date, the assignment shall be considered cancelled, and the Retainer is non-refundable.

**Limit of Liability:** While Photographer will take reasonable precautions, there are occasions when a problem may arise due to the sometimes unpredictable nature of assignment photography. Additionally, there is the unlikely possibility that images may be lost, stolen or destroyed for reasons in or beyond our control. Liability is limited to a refund of any payments received, or part thereof according to the percentage of images supplied.

**Copyright:** The copyright of photographs remains with the Photographer. Clients shall be granted a usage license for personal, non-commercial reproduction of delivered images. Sale, publication or any commercial use of the photographs is not allowed without prior written permission from the Photographer.

**Additional Insipid Text:** This agreement contains the entire understanding between the Clients and the Photographer. A signed "*Kai Mountain Ventures Photography Contract*" and payment of the Retainer are necessary to confirm the stated wedding services from the Photographer.
